



DRAFT MINUTES
MCUSD Board Meeting
District Office Board Room
May 9, 2024

1. Open Meeting:

President Jennifer Kiser opened the meeting at 4:30 PM. Present were Robert C. Hill, Kimberly Harper, Bob Morse, Bob Collins, and Jeff Aranguena, the Superintendent.

A. Public Comment for Closed Session:

2. Closed Session: As there were no public comments, the Board entered into closed session at 4:32 PM.

B. PUBLIC EMPLOYEE DISCIPLINE/DISMISSAL/RELEASE [Gov. Code § 54957]

In moving to Open Session at 5:30 PM there were technical issues with the Zoom.

3. Reconvene in Open Session: The schedule was adjusted, bringing forward presentations while working through the Zoom issue.

B. Pledge of Allegiance: Led by President Kiser

C. Items not on the Agenda:

The Superintendent would like to add the Golf Team presentation and move the Student Board Member Report forward to 3E & F.

The Superintendent will also move item 10B, Athletic Budget Development and Update to be presented along with Item 11B, Athletic Facilities/Fields Priority List Update

E. Golf Presentation: Coach Blessing introduced students Lobaugh and Verceles who competed in the CIF-SJS VI Golf Tournament. The students shared their experience with the board.

F. Student Board Member Report: Maegan Matchett shared the end of the year ASB plans for prom and graduation as well as her plans for the future. The Board presented Ms. Matchett with a plaque for her service as the student board member for the 2023-24 school year.

The Zoom connected at 6:05 PM at which time the board proceeded with the meeting.

A. Announce Closed Session Action: It was announced that in closed session the Board conducted the annual evaluation of the Superintendent

D. Approval of the Agenda:

Moved by Mr. Collins to approve the agenda, seconded by Mr. Morse.

The regular MCUSD meeting was recessed to open the Public Hearing for both the MCUSD and MCOE at 6:09 PM.

4. Public Hearing: By-Trustee Area Election System: opened for mcoe/mcUSD

A. Pre-map Public Hearing #2: Legal representative David Soldani confirmed that the demographer has reviewed the current County Board of Supervisor maps and found them to be compliant with the Fair Maps Act and aligned with the criteria needed.

Mr. Soldani proceeded to share with the room questions and answers that had been provided to the board regarding pros and cons, costs, litigation/liability, and possible effects on board seats.

The question of representation was once again brought up. It has been presented that by moving to a by-trustee voting system, voters in districts would have no say over the representation of the high school. Mr. Soldani repeated his prior response which is that no matter which district a trustee represents, whether they are voted in by an at-large or a by-trustee system, the first responsibility of every board member is to every student in the school district, not to an individual school site, not to a building.

K Monson: Ms. Monson echoed the lawyer's response that the duty of each representative is to all the students in the district as a whole.

B Cone: Ms. Cone spoke of appreciation for the board going through the process and shared the parallel she sees of Mariposa being able to vote for congressional representation from their county, and not having that voted on by the entire state. Speaker: It was shared that the board should make decisions based on the entire student population

L Eidelheit: Ms. Eidelheit asked the board to please move to a by-trustee area voting process as it is in the best interest of the school district and would align with how the board of supervisors is elected. In response to a comment regarding Mariposa not having protected classes, she spoke to the largest native american and hispanic communities.

B Collins: Ms. Collins spoke of choosing a voting process for the right reasons.

M. Ahmadi: Mr. Ahmadi spoke in favor of a by-trustee area voting process

Burnikoff: Letter read in support of shifting to by-trustee area voting process

Mr. Soldani responded to board questions regarding if they chose to remain with an at-large voting process and they were served with a lawsuit. He let the board know that what would most likely happen is they would receive a letter informing them that they needed to change to by-trustee area voting and at that point they should not fight it but proceed with the process to change as there has not been one example of a district winning a CVRA, FVRA, FMA suit. Once a letter is received, the district must respond to that request and is required to pay whatever fees the letter writer has incurred, this usually begins at \$30K.

It was confirmed that the first of two Post-Map Public Hearings will take place on May 23, 2024 at 4:30 PM.

The MCUSD/MCOE Public Hearing was closed at 6:53 PM to reopen the regular MCUSD meeting.

Based on the interest in item 13A, the Board moved this item up.

Trustee Collins read BP 6144, Controversial Issues, and spoke of the policy relating to his belief that all discussions should be allowed in science instruction. Discussion and clarification between board members ensued. Questions were raised as to what are the expectations for teachers, class discussions if all topics are allowed.

B Collins: Ms. Collins delivered a revised draft of the language she would like to submit for consideration to the board

B Moore: Mr. Moore spoke in opposition to CSBA language

K Monson: Ms. Monson spoke in support of the CSBA language

C Dunn: Mr. Dunn spoke in opposition to CSBA language

R Shull: Mr. Shull spoke in opposition to CSBA language

Mr. Morse clarified that the proposed language is not new, the district is simply behind in updating this policy.

C River: Ms. River spoke as a tribal member and of the CSBA language in place to protect all peoples of varying views

Trustee Collins spoke again of not expecting teachers to share their religious views, but to allow students to ask questions, and for educators to make decisions about how they will respond.

Trustee Hill added that no one is trying to push religion into the classroom, and wants students to have their freedom of speech to ask questions.

Trustee Morse added that while freedom of speech continues to be raised, the board's legal representatives have stated that this is not a freedom of speech issue.

Trustee Kiser shared information regarding religion being allowed to be discussed in schools, and other policies in place to protect the language in the science policy. She believes religious discussion in science class is already being governed.

Trustee Collins provided new language for consideration. *"Philosophical and religious theories that are based, at least in part, on faith and are not subject to scientific test and refutation can be responded to pursuant to existing board policies; BP 6141.2, BP 5145.2, and BP 6144."*

Moved by Mr. Hill to submit new language to the legal team, and bring back the new language to the June meeting as a first read/discussion, seconded by Mr. Collins

C River: Ms. River of the Southern Sierra Miwok spoke of AB1703, the Indian Education Task Force Act, which allows for the Miwok to create a steering committee to write regional curriculum and are hoping that some of those

funds could go towards initiating the task force and help as they work towards rolling out the curriculum as part of the mandate.

Ms. Azevedo added that 100 % of the gate fees pay for the officials, and added that with the development and addition of an athletic budget, the coaches are feeling very supported. The process began with a needs assessment from the coaches and has allowed for the planning of replacing items including uniforms and equipment on a cycle.
